To meet the needs of all of our students, we continue to offer speech therapy, a Resource Specialist Program, a school counselor, an after-school program open until 6 p.m., classroom aides, home-to-school transportation when available, a reading assessment and support program, many enrichment and arts activities, student council, a robust music program, athletic teams, an annual eighth-grade trip and a library program. We bring and use as many resources as we can to help each student live up to his or her potential.
